

FUNERAL SERVICES AGREEMENT

Agreement between _____ located at _____ (the Funeral Home) and the Memorial Society of Georgia, Inc., a nonprofit corporation with an office at 1911 Cliff Valley Way, N.E., Atlanta, Georgia (the Society).

1. Services Furnished

The Funeral Home will furnish to the family or estate of a deceased member of either the Society or another memorial or funeral society with whom the Society has a reciprocal relationship those services set out in the attached Schedule at the prices stated therein. Note: The Schedule is periodically adjusted.

2. Referral of Members

The Society will list the name and address of the Funeral Home in the communication vehicles that are available to members and prospective members of the Society and will refer to the Funeral Home all Society members who have indicated a preference for the Funeral Home. It is understood that the Society will have similar agreements with other funeral homes in different geographical sections of the State of Georgia.

3. Charges and Billing

- a. Funeral Services – All charges for funeral services furnished will be billed to and collected from the family or estate of the deceased members. The Society will not be responsible or liable for such charges, as a guarantor or otherwise.
- b. Records Charge – In order to defray the expenses incurred by the Society in creating and updating the records referred to in paragraph 4, the Funeral Home will collect, on the Society's behalf and remit that records charge set out in the Schedule for each member for whom services were furnished during the preceding calendar month.
- c. Copies of Billings - The Funeral Home will furnish to the Society the following information: name of the deceased member, date of the death, date of the cremation or burial, and the type of services furnished. Payment Terms – Payment terms for charges under this agreement are 30 days net.

4. Record Creation and Maintenance

The Society will endeavor to obtain from each member a completed form which sets out information required for a death certificate form and that member's

desires concerning funeral services (a prearrangement form). The Society will supply to the Funeral Home a copy of the prearrangement form of each member who has indicated a preference for the Funeral Home. The Funeral Home will maintain such records for the mutual convenience of the Funeral Home and the Society members. In the event this Agreement is terminated, the Funeral Home will return promptly all such records to the Society.

5. Publicity

Neither the Society nor the Funeral Home may use the other's name in publicity material without the written consent of the other, except that the Funeral Home hereby grants permission to use its name on the Society's standard forms and website.

6. Term of Agreement

This agreement will remain in effect until terminated by either party, upon 120 days' notice to the other by certified mail; however, the services and prices set out in the attached Schedule may be renegotiated during the month of September of any year if the party who wants to open negotiation gives the other written notice by August 1 of the year.

FEES for SERVICES

SIMPLE CREMATIONNo greater than \$1095.00

Includes transportation of the body to the funeral home, a simple cremation container and filing of paper work.

SIMPLE BURIAL.....No greater than \$2,050.00

Simple Burial includes removal of body; care, dressing and casketing of body; filing of paper work; transportation to cemetery. A cloth covered casket is included.

Simple burials and simple cremations do not include space and time at funeral home for memorial service, committal service nor embalming. This service may be arranged with the funeral director or at a place of the members choosing. Simple Burial does not include cemetery plot or opening of the grave; the funeral directors may make the contact for you.

TRANSPORTATION beyond 30 mile radius of funeral home, per vehicle one way only, per mile.....\$1.50

MEALS AND LODGING EXPENSE for funeral home personnel in connection with non-local transportation.....at cost.

There will be a charge for DEATH CERTIFICATES.

The Cooperating Funeral Director will remit a records charge of \$15.00 to the Memorial Society of Georgia for each member for whom services are provided.
